Committee description

The Sponsorship Committee strives to find opportunities for our corporate sponsors to engage with and support ADRP's mission and membership with a specific focus on financial commitments to the International Conference.

Chair responsibilities

- recruit and lead a diverse and growing team of volunteers with a range of experience in donor relations and variety of industries
- act as liaison with the ADRP Board of Directors and the ADRP Volunteer and Member Experience Committee on behalf of your committee
- attend regular ADRP Volunteer Summits at which you will report on committee updates
- manage scheduling and agendas for regular virtual meetings, provide support and guidance to committee members, and assign sponsorship committee tasks as needed
- drive communications to past, current, and potential sponsors
- coordinate with regional conference sponsorship chairs to ensure sponsors are solicited strategically

Appointment begins immediately following the ADRP International Conference and the rotation of the ADRP Officers and Board of Directors, and ideally will last for at least two years. After two years, the co-chairs have the option to renew or step down. Whoever leaves a vacancy is responsible for helping to recruit a replacement and if possible, giving one month's notice to the Board Liaison and the Volunteer and Member Experience Committee.

Committee responsibilities

Time commitment

The Sponsorship committee meets virtually each month for about one hour. Individual responsibilities, such as outreach and follow-up, can include an additional two to three hours a month.

To gain the most from this volunteer experience, members ideally would commit to two years. Members who wish or need to end their volunteer term before completing then should notify the chair/co-chair and the Volunteer and Member Experience Committee at least one month before stepping away.

Committee structure

The committee contains a chair, a board liaison, and members. It is also recommended that the Executive Director or ADRP staff appointee attend these meetings.

Goals and strategies

- Annually update the Partnership Prospectus document which outlines sponsorship packages and ad hoc opportunities to support the International Conference.
- Build relationships with past, current, and potential corporate sponsors
- Track outreach

- Solicit corporate sponsors for financial commitments
- Provide guidance and answer questions of current and potential corporate sponsors
- Gathering feedback from sponsors, including testimonials, post-conference
- Produce and conduct stewardship throughout the year for past ADRP sponsors, including post-conference acknowledgements
